## Code of Conduct- Children / Youth

#### Introduction

This Code of Conduct applies to all children attending Port City Christian Church's Children's / Youth activities. A code of conduct for children helps to explain their rights and responsibilities when taking part in our church's activities.

For this to work, children need to be able to develop the code for themselves, with your assistance. Codes of conduct for children / youth have been shown to be a great exercise to help them develop their own sense of fair play and mutual respect. When children / youth 'own' the code they will protect it and support it.

An effective code of conduct for children:

• Is discussed and debated by children / youth; Addresses matters that are important to children / youth in our church activities; Is age appropriate; Is in simple language; Is accepted as fair and reasonable by children and adults; Is widely promoted; and Must be explained and discussed with children / youth when they first join the Church's activities.

## Policy Overview

All children / youth participating in Port City Christian Church's Children's and Youth Activities agree:

- 1. **We will** be respectful and friendly to everyone and welcome new children joining the group.
- 2. **We** will follow all instructions the first time and play by the rules.
- 3. **We will** have a say about the activities we take part in.
- 4. We will report any concern or worries about safety.
- 5. We will not be a bully!
- 6. We will not leave the group without telling an adult supervisor or leader where we are going.

In the event that a child/ youth's behaviour is unacceptable then the following strategy will be implemented:

- 1. Five Fingers" Name, 5 words only, repeat, quiet and firm, clear instruction "thanks".
- 2. Parallel Positive -Compliment good behaviour rather than focusing on only bad behaviour.
- 3. Discuss rules/rights, all informed, always give a choice, effective warning (to include number of remaining opportunities to comply), in-class action, time out (1min/year age with appropriate supervision).
- 4. If child's / youth's behaviour continues to be unacceptable (or is deemed so serious as to pose a risk to themselves or others), parent / guardian will be notified and asked to remove them from the group and notified of expectations on their return.
- \*Discipline of a child/ youth is the responsibility of the leaders and the Children's Church Ministry Coordinator/ Youth Leader. Serious discipline issues, which may require action outside the program, such as suspensions, will be brought to the attention of the Children's Church Ministry Coordinator/ Youth Leader if required. A leader is required to respond appropriately rather than react positive encouragement is always better than negative punishment.
